

Privacy Notice for Seminars, Training, and Other Activities

Last updated: 25 July 2024

1. Scope and purpose of the personal data protection policy

This personal data protection policy has been prepared for users who wish to participate in activities organized by the Office of the Securities and Exchange Commission, Thailand.

Under this personal data protection policy for seminars, training, and other activities, the following terms shall have the meanings set forth below.

“SEC Office” means the Office of the Securities and Exchange Commission, Thailand.

“SEC Privacy Notice” means the Personal Data Protection Policy of the Office of the Securities and Exchange Commission, Thailand.

2. Personal data collected by the SEC Office

The SEC Office collects only the personal data necessary for organizing its activities, such as:

Personal data	For example, title, full name (Thai/English), photographs, and video recordings.
Contact information	Information for communication purposes, such as mobile phone numbers and email addresses.
Qualification data	For example, organization name and position.

3. Methods of collecting and obtaining personal data

The SEC Office collects and obtains your personal data through the following channels:

3.1 Personal data obtained directly from you when you provide information to participate in an activity or while participating in an activity.

3.2 Personal data obtained from a company or representative authorized by you to register you for an activity.

4. Purposes of data processing

The SEC Office will process your personal data to provide details and carry out actions related to the organization of its activities, which may be categorized as follows:

The personal data collected may be disclosed in accordance with the SEC Office's duties, as provided in [Section 5](#) of the SEC Privacy Notice.

6. Storage and retention period of personal data

The SEC Office has implemented security measures for personal data in accordance with the standards prescribed in the Notification of the Personal Data Protection Committee Re: Security Measures for Personal Data Controllers B.E. 2565 (2022) and other relevant standards.
